Resolution No. R -14-24-06

TITLE: A RESOLUTION AUTHORIZING THE MAYOR TO SIGN AND EXECUTE A CONTRACT BETWEEN THE VILLAGE OF EAST SPARTA, OHIO, AND THE BOARD OF TRUSTEES OF PIKE TOWNSHIP, STARK COUNTY, OHIO FOR POLICING SERVICES TO PIKE TOWNSHIP.

WHEREAS, The Stark County Sheriff will be providing policing services to the village of East Sparta up to 40 hours per week devoted to patrolling in the geographical area of the village beginning January 1, 2025, through December 31, 2025.

WHEREAS, The Pike Township Board of trustees' desires to obtain 16 hours per week policing services through the village of East Sparta beginning January 1, 2025, through December 31, 2025.

WHEREAS, A contract to provide policing services by the village of East Sparta to Pike Township has been prepared and available for signature and execution. A copy of said contract is attached hereto and incorporated by reference.

NOW THEREFORE, be it ordained by the Council of the village of East Sparta, State of Ohio, that:

SECTION 1:

The Council of the village of East Sparta, Ohio has reviewed the proposed contract between the village of East Sparta and the Board of Trustees of Pike Township for the providing of 16 hours per week of policing services to Pike Township at the rate of \$3,700.00

dollars per month for a total of \$45,000.00 per year, and hereby approves and accepts said contract. The council hereby authorizes the mayor to sign and execute the contract.

SECTION 2:

This resolution is declared an emergency measure immediately necessary for the preservation of the health, safety, and welfare of the community and for the additional reason it is necessary to promote the policing services to the Pike Township community which directly benefits the village of East Sparta. Provided it receives the affirmative vote of two-thirds of the elected members to council, it shall take effect and be enforced immediately upon its passage and approval by the mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

AGREEMENT FOR POLICE SERVICES BETWEEN THE VILLAGE OF EAST SPARTA STARK COUNTY OHIO AND PIKE TOWNSHIP STARK COUNTY OHIO

WITNESSETH:

WHEREAS, the Pike Township Board of Trustees desires to obtain policing services by and through the Village of East Sparta, who has contracted policing services through the Stark County Sheriff's Department.

WHEREAS, the Stark County Sheriff will provide policing services to the Village of East Sparta up to 40 hours per week devoted to patrolling the geographical area of the Village. The Village and the Board of Pike Township Trustees have agreed that Pike Township shall be provided 16 hours per week of policing services, through the Stark County Sheriff, which shall be derived from the Village's 40 hour permitted time period.

NOW, therefore, in consideration of the covenants and promises herein made, the undersigned parties do agree as follows:

- 1. The Village of East Sparta, through the Stark County Sherriff's Department, shall provide 16 hours of policing services, which includes patrolling in the geographical border of Pike Township. The Stark County Sheriff, in coordination with Pike Township officials and the Mayor of the Village of East Sparta, will schedule the Sheriff's deputy based upon call demands and other factors within the Sheriff's discretion. Said scheduling shall remain in the Sheriff's ultimate discretion. Should special policing needs be required by Pike Township, such needs shall be reviewed with the Village of East Sparta's mayor prior to the utilization of the policing services.
- The Sheriff and/or deputy sheriff shall possess the same powers as the Township with respect to policing and all powers necessary and incidental thereto.
- 3. The Village shall provide all vehicles, equipment, and supplies necessary for the performance of policing services to the Township. The Township agrees to pay for all fuel costs for the police

vehicle whether it is used in the Village or Township. Any routine maintenance on the vehicle will be performed by the Stark County Sheriff's Department. If the Sheriff's Department is unable to perform the routine maintenance of the vehicle, the Sheriff will transport the vehicle to an outside service provider designated by the Village. The costs of this maintenance work will be paid for by the Village.

- 4. Pike Township Board of Trustees agrees to pay the Village the amount of \$3,750.00 dollars per month for a total of \$45,000.00 per year for policing services performed by the Stark County Sheriff's Department in the Township. Said payment shall be made to the Village of East Sparta.
- 5. Policing Services provided by the Village of East Sparta, through the Stark County Sheriff, shall be in effect January 1, 2025, through December 31, 2025. Renewal of this contract shall be made in writing Sixty Days (60) prior to its expiration.
- Termination of this contract may be by a party upon Sixty days (60) written notice to the other party.
- 7. This writing embodies the entire agreement between the parties. Any change to this Agreement shall be made in writing, mutually agreed upon by the parties.
