Motion to make shelters available at SV pool property, through civic association pending agreement with Linda to manage by Hessedence. Seconded by Stelluto. Roll call 6 yes, 0 no. Motion carried.

Cyperski- legal update: Reminded reelected members they need to complete public records and sunshine law training. Need to post Public Records policy at all buildings and on website. Contacted Stark County Health Dept. about Carpenter property.
